SWIMMING LEVELS

Some of the skills covered in each level:

PARENT/ CHILD AQUATICS-	Start as young as 6 months old, parent/guardian gets in the child with the water; no prior swim experience
LEVEL A-	New to the water, but willing to learn. No prerequisites. The emphasis will be on water exploration, safety, and primary skills.
LEVEL B -	Able to float unsupported for at least 5 seconds on front and back, swim 5 yards (any stroke), and tread water for 15 seconds
LEVEL C -	Can swim 15 yards front crawl using rhythmic breathing. Also able to swim 15 yards of back crawl and tread water for 30 seconds.
LEVEL D -	Child is able to swim 25 yards of front and back crawl, 15 yards of breaststroke, and tread water for 1 minute.

Lessons will be 30, 45, or 60 minutes in duration. Classes will be held in a pool of your convenience and will maintain a student/teacher ratio of no more than 3:1. Lessons must be paid after each lesson or may be purchased in advance in series of 10 lessons. Parents/Guardians must be always present during the swim lesson; however, it is not required that you stay on the pool deck. Since scheduling of an appointment involves the reservation of a time specifically for you, **a minimum of 24 hours notice is required for re-scheduling or canceling an appointment.**
